

TERMS AND CONDITIONS OF PURCHASE AND USE OF TICKETS TALENT ARENA 2026

Last updated: October 2025

These terms and conditions govern the registration, purchase, use and management of tickets for the Talent Arena 2026 event, organised by Fundació Barcelona Mobile World Capital Foundation (hereinafter, "MWCcapital"), with registered office at Pl. de Pau Vila 1, Sector 2C (Palau de Mar Building), 08039 Barcelona (Spain) and VAT number G65760431.

The ticket registration and sales system is managed by MEETMAPS, S.L., with tax identification number B66469859 and registered address at C/ Llull 321, 08019 Barcelona, which acts as the data processor on behalf of MWCcapital, in accordance with the provisions of the General Data Protection Regulation (GDPR).

By registering or purchasing a ticket to attend the event, you accept these terms and conditions, as well as MWCcapital's Privacy Policy, available at <https://mobileworldcapital.com/privacy-policy>.

1. Types of tickets

The Talent Arena 2026 event is free of charge and general attendance does not incur any cost nor does it constitute a service provision subject to financial compensation.

However, two types of accreditation are available:

- GENERAL registration (free): gives access to the event and activities open to the public, with possible capacity limitations.
- XPRO PASS ticket (paid): grants full access to the event and to exclusive activities or areas linked to this category.

The selected type guarantees access to the event and activities associated with each type, as indicated on the official website <https://talentarena.tech>

General registrations (GENERAL) are completely free of charge and do not imply any contractual relationship or financial compensation between the participant and MWCcapital.

2. Official sales and channels

Ticket sales and registration will be carried out exclusively through the official forms available at the following links, managed by MWCcapital and the technical provider MEETMAPS, S.L.:

Any tickets purchased through other channels or unauthorised third parties may be considered invalid, without the right to a refund or access to the event.

3. Refund policy

No refunds or ticket exchanges will be made for any reason, including inability to attend the event, schedule changes, errors in the purchase process, or loss of accreditation.

Refunds will only be issued in the event of total cancellation of the event for reasons attributable to the organisation, and always using the same payment method used for the purchase.

4. Loss or misplacement of tickets

Tickets are nominative and the bearer is responsible for keeping them safe. MWCcapital is not responsible for loss, theft or failure to present accreditation.

In the event of loss, no duplicates or replacements will be issued.

5. Transfer or change of ownership

Tickets are personal and non-transferable.

However, MWCcapital may exceptionally authorise a change of ownership, upon written request from the purchaser and with the express authorisation of the organisation, within the period determined by the latter.

The request must be sent to the contact address info@talentarena.tech, indicating the details of the ticket and the proposed new attendee.

MWCapital will assess the request and communicate its authorisation or refusal in writing.

6. Access and identity verification

To access the event, it will be mandatory to present the ticket in digital or printed format, together with an official identity document (ID card, passport or other valid document) that allows verification that the person attending is the ticket holder.

MWCapital reserves the right to deny access if fraudulent use, manipulation or falsification of the ticket is detected, without this giving rise to any right to a refund.

7. Modification or cancellation of the event

MWCapital may modify the dates, times, location or activities of the event for justified reasons (security, force majeure or organisational needs).

In the event of total cancellation, the cost of paid tickets will be refunded as indicated in section 3. In the event of postponement, tickets will remain valid for the new date.

8. Recordings, images and image rights

During the event, audiovisual recordings and photographs may be taken for informational, institutional or communication purposes.

By attending the event, participants authorise MWCapital or collaborating entities to capture and use their image for non-commercial purposes, in accordance with MWCapital's Privacy Policy.

9. Personal data protection

Personal data provided during the purchase or registration process will be processed by MWCapital for the purpose of managing registration, payment, access control and participation in the event, based on: (i) the performance of a contract (Art. 6.1.b GDPR) and (ii) the legitimate interest of MWCapital (Art. 6.1.f GDPR) to ensure the safety and authenticity of attendees.

The provider MEETMAPS, S.L. acts as the data processor, in accordance with Article 28 of the GDPR.

11. Applicable law and jurisdiction

These conditions are governed by Spanish law.

Any dispute arising in relation to their interpretation or execution shall be submitted to the Courts and Tribunals of the city of Barcelona, expressly waiving any other jurisdiction that may apply.
